- 1. (a) When was Medicare passed by congress? (b) What is it? (c) Can anyone get Medicare and if not what allows a person to quality? (d) What services does it offer (be sure to note the two major parts of Medicare and how the parts differ both in terms of services and financing)? (e) Where does the money come from to pay for the services?
- 2. (a) What is the similarity between traditional Medicare and Medicare Advantage? (b) What is the difference? (c) Why would someone choose traditional Medicare over Medicare Advantage? (d) Why would someone choose Medicare Advantage over traditional Medicare?
- 3. (a) What is OASDI (what do the letters stand for)? (b) Who can qualify for OASDI? (c) For each group within OASDI, who qualifies, when do they qualify, what do they receive, and what must they do to qualify? (d) what is COLA and why is it important to those receiving OASDI?
- 4. (a) Where does the money come from to pay for OASDI? (b) Provide a figure to explain how the funding and payouts work for OASDI (e.g., where does money come from for OASDI and where does it go)? (c) Explain why it appears that OASDI is going to go bankrupt. (d) Describe four changes that could be made to prevent OASDI from going bankrupt.
- 5. (a) Describe three amendments that were made to OASDI in 1982. (b) what was the purpose of the amendments? (c) According to Hillier and Barrow, why do some want to privatize OASDI? (d) How would this be done? (e) What are the problems with this approach? (f) Describe three problems with pensions as a means of taking care of the elderly fianancially.
- 6. (a) How does social class affect the elderly? (b) What is meant by social mobility? (c) Is it desirable? Explain. (d) According to Hillier and Barrow, how do the rural elderly compare to urban elderly? (e) How do reverse mortgages affect the elderly? (f) What is relative deprivation and how does it affect one's life satisfaction? (g) What are businesses, communities and others doing to assist the low-income elderly?

- 3. (a) What factors have contributed to homelessness? (b) How is gentrification (a form of urban renewal) related to the homeless? (c) Some low-income older persons have been found to prefer a low-end hotel room over a nursing home. Why is this?
- 4. (a) What physical characteristics of a home would older persons like to have if they don't already, according to Hillier and Barrow? (b) What factors contribute to an older person relocating to a new home? (c) What problems do they experience when they have to relocate?
- 5. (a) If you visited a nursing home to evaluate its quality for a loved one, (a1) when would you make your visits and (a2) what would you look for? (b) Describe the two best indicators of quality. (c) How could the ombudsman program be useful? (d) Describe several ways (e.g., sources of funding) that older persons pay for NH care?
- 6. (a) Which is more expensive: assisted living (AL) or nursing home (NH) care? (b) Why? (c) How do older persons pay for NH care? (d) What are several different scenarios that could happen if a person doesn't have enough money to pay the monthly NH charge?
